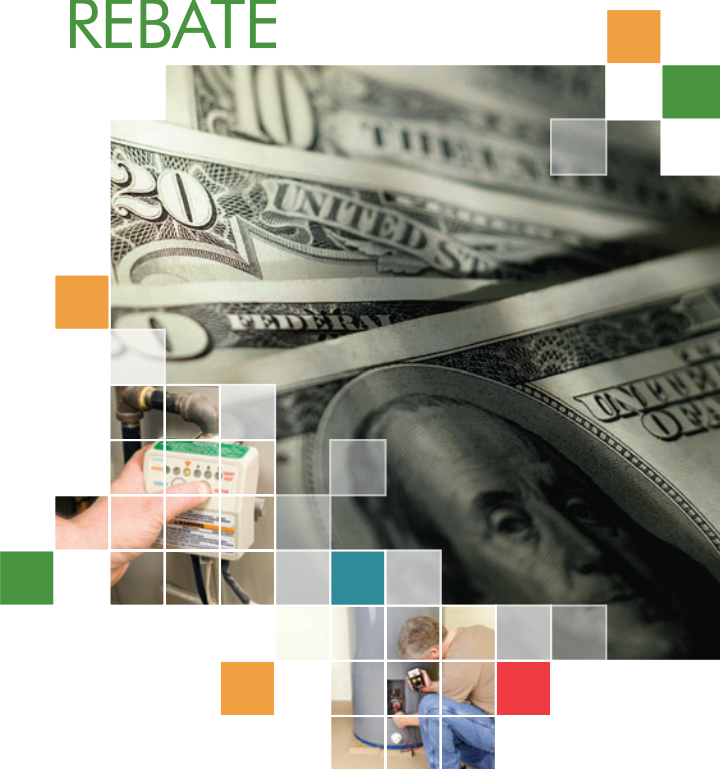

Only approved equipment is eligible for energy efficiency rebates. After purchasing and installing qualifying equipment:

1. Complete this Equipment Application, including signature(s).
2. Attach a dated **invoice** and **sales receipt** from your dealer, including manufacturer's name, model/serial number and quantity of equipment purchased and installed. **Equipment must be installed between Jan. 1, 2012, and Dec. 31, 2012. Rebate applications must be postmarked by Jan. 31, 2013, to qualify for 2012 rebate program.** Equipment included in the EnergyAdvantage® New Homes program comprehensive incentive is not eligible for additional incentives in the Residential Equipment program.
3. Allow six to eight weeks for processing.
