Programs are effective Jan. 1, 2017, through Dec. 31, 2017, and are subject to change. Complete program details and rebate forms are available at www.midamericanenergy.com/ee. **Qualifying appliances and equipment must be purchased and installed in 2017 in order to receive a rebate.** Rebate applications must be postmarked by March 31, 2018, to qualify for 2017 rebates.

HomeCheck®

Free on-site HomeCheck energy assessment to eligible customers of MidAmerican Energy; energy expert may install free energy-saving items. MidAmerican Energy must provide the primary heating fuel to customer's home. Renters need owners' approval, home must be built before Jan. 1, 2007, and homes on farms are eligible. On-site assessment must be completed prior to insulation or home sealing installation to qualify for a rebate.

\$200 available to customers who upgrade three qualifying recommended items within 12 months after the assessment.

Insulation and Home Sealing
