- Purchase, install and begin to utilize the charger between March 15, 2019 and December 31, 2019.
- Consent to onsite inspections and MidAmerican Energy Company's use of charging data.
- Provide a copy of the invoice or itemized receipt for the charger with this form.
- Agree to make available the charger for public or employee use.
- Install a pedestal mount, dual-port charging unit.

**NON-RESIDENTIAL ELECTRIC VEHICLE CHARGER INCENTIVE TERMS AND CONDITIONS**

To be eligible for the Non-Residential Electric Vehicle Charger Incentive, you must:

- Be a MidAmerican Energy Company non-residential electric customer in Iowa whose account is in good standing.
- Install an approved level 2 charger on an electric meter billed under a non-residential MidAmerican Energy Company account.
- Purchase, install and begin to utilize the charger between March 15, 2019 and December 31, 2019.
- Consent to onsite inspections and MidAmerican Energy Company use of charging data.
- Provide a copy of the invoice or itemized receipt for the charger with this form.
- Agree to make the charger available for public or employee use.
- Install a pedestal mount, dual-port charging unit.

Only one incentive per non-residential electric meter and customer. Free chargers, used chargers, portable chargers and rebuilt chargers are not eligible for incentives. The incentive amount shall not exceed the customer's actual cost.

Incentives are limited and may not be offered the entire year. MidAmerican Energy Company reserves the right to cancel or modify these incentive programs at any time in its sole discretion.

MidAmerican Energy Company is collecting information to better plan for the use of electric vehicles in its service territory. Therefore, by receiving the incentive you agree that your electric usage and the information you provide in the incentive form can be used for this purpose. You also agree that MidAmerican Energy Company may contact you to obtain additional information related to this program and your use of an electric vehicle charger. You also agree that MidAmerican Energy Company may enter your property with advance notice to inspect the installation and use of the charger.

MidAmerican Energy Company is not making and disclaims any representation, warranty, guarantee or covenants, whether express or implied arising out of this incentive program, installation or use of the charger. All chargers must be installed by qualified and licensed contractors in accordance with local codes, permitting and inspection requirements.
