## 2021 ILLINOIS BUSINESS REBATE APPLICATION



To apply, **complete all required sections of this application** or application will be rejected. Applications must be submitted within six months of dealer invoice or by Dec. 31, 2021, whichever comes first. Equipment must be installed and operating between Jan. 1, 2021, and Dec. 31, 2021, prior to submission of final rebate application.

Rebates are issued on a first-come, first-served basis. Please allow 14 days for rebate processing.

For custom equipment projects, use the Custom Project Preapproval application available at **MidAmericanEnergy.com**.

Commercial new construction projects, including multifamily new construction are not eligible for prescriptive rebates. All commercial new construction projects, including multifamily projects, must participate in the Commercial New Construction program in order to receive rebates.
