Nonresidential customers must submit a paper application.

Applications must be submitted by January 31, 2026. Equipment must be purchased between January 1, 2025, and December 31, 2025, and installed and operating prior to submitting the final rebate application. Please review the [Qualifications and Conditions](#) located at the end of this document before signing and submitting this application.

Rebates are issued on a first-come, first-served basis. Please allow 14 days for rebate processing.

A dated sales receipt or invoice including itemized labor and equipment costs, manufacturer's name, model number and quantity of qualified equipment purchased must be included with the completed rebate application.

- Participants must be located in MidAmerican Energy Company's Nebraska service territory with a rate designation of Small Volume Firm (SVF).
- MidAmerican Energy Company must directly provide the natural gas to the equipment for which the rebate is being paid. Additionally, customer must use natural gas supplied directly by MidAmerican Energy Company as their primary heat source.
- Qualifying equipment must be new, installed on the premises and must not be purchased for resale. Please see the [specific equipment qualifications](#) for details.
- Customers are responsible for ensuring that the equipment installed for these programs meets all applicable codes, standards and regulatory requirements.
- Customers agree to allow MidAmerican Energy Company, its program implementation contractors and their subcontractors to access their property for the purposes of delivering program services/equipment made available through MidAmerican Energy's energy efficiency programs.
